The Chicago Central Area Committee was founded in 1956 by executives from Chicago's large corporations, entrepreneurs, and women from smaller firms. The organization is a coalition of business institutions and non-profit organizations that seeks to influence strategic planning choices in downtown Chicago and facilitates discussion on some of the most challenging issues that affect America's third largest city. The collection includes board meeting minutes, newsletters, newclips, correspondence, annual reports, financial statements, audits, studies, photographs, plans, books and other documents related to various development projects in downtown Chicago and the Chicagoland area from the 1950s to the early 2010s.

Biography/Profile

The Chicago Central Area Committee (CCAC) was founded in 1956. It is a coalition of business executives and leaders of non-profit organizations with the mission to support strategic planning and development activities to strengthen Chicago's competitive edge and enhance its urban quality of life. Since its founding in 1956, CCAC members have worked in partnership with the City of Chicago on many development plans for downtown Chicago, including most recently the 2009 Central Area Action Plan. Since its creation, CCAC has dedicated its efforts toward research, study, and planning for the Chicago Central Area. CCAC worked in partnership with the City of Chicago to develop and maintain a strong and dynamic center for the Chicago metropolitan area and to preserve and improve Chicago as a center for commerce, industry, and culture. Over the years, the leadership of CCAC consisted of CEOs and top executives of various companies from real estate development, architecture and design companies, consulting firms, financial services, institutions of higher education, law firms, non-profits and other businesses with offices in Chicago. The expertise of CCAC board members helps the organization focus on a broad array of issues and provide solutions for a city, regional, national and global issues.

One of the first initiatives undertaken by CCAC was the Central Area Plan prepared in 1958 in conjunction with the newly formed City Department of Planning. It focused on the development of the central business district along the lakefront, and included several landmark projects that were realized in 1960s. These included the new Civic Center, the Federal courthouse, the new McCormick Place, the relocation of the University of Illinois, new parkland along the lake and extensions of Columbus and Wacker Drives (Source: CCAC Annual Report 1985).

In subsequent years and decades, CCAC continued to focus on the development of Chicago's Central Business District. The Chicago 21 Plan proposed in 1973 outlined a broad range of improvements for the central area and adjacent neighborhoods, including improvements to the pedestrian sidewalks and passages between downtown buildings, landmark preservation, creation of rapid transit connections to O'Hare International Airport, a State Street transit mall, riverfront development, and a pedestrian walkway network. In 1983 CCAC developed the 1983 Central Area Plan that addressed the development of geographical regions surrounding the Central Business District — the Lakefront, South Loop, West Loop and North Loop. The plan served as a comprehensive framework for future development and CCAC had several task force work groups that focused on a broad range of issues — Transportation, Housing, Sports Complex, Cultural and Economic development. Other major initiatives undertaken by CCAC included: the Revitalization of State Street, the Central Area Circulator Transit System, the Chicago Riverwalk Master Plan, the Arts District Plan, Lakefront Millennium Project, Vision 2000 Plan, projects that focused on improvement of the Illinois Medical District, Central Area Transportation and many others.
